PM Imran Khan defers lockdown, seeks Pakistan Army's help in enforcing COVID-19 SOPs

SLAMABAD - Prime Minister Imran Khan recently deferred imposing a broad lockdown and sought help from the Pakistan Army in the enforcement of coronavirus SOPs.

He once again appealed to the masses to follow protocols, "else we will be facing the same situation India currently is in," he warned. "The situation is changing very fast and we might have to impose a lockdown in the days to come, which would be devastating for the economy and the poor."

A meeting of the National Coordination Committee (NCC) was held today with Prime Minister Imran Khan in the chair to review the prevailing coronavirus situation in the country and take a decision on imposing lockdown in cities with a high positivity ratio.

The session was attended by the chief ministers, ministers and chief secretaries of the provinces, who reviewed the latest COVID-19 numbers and decided to impose further restrictions as the third wave of coronavirus wreaks havoc in Pakistan.

"The government has expanded the capacity of hospitals during the past year. Had we not increased the facilities we might be facing a very bad situation," the prime minister said.

He said that if we strictly follow SOPs till Eid, we may not need to take the extreme steps India has been taking.

PM Imran also asked the ulema to play their role in creating



awareness, like they had last Ramadan.

"Today, people are asking me to impose a lockdown, but we are not taking such an extreme step for now. I am more concerned about the poor and daily wagers," the PM explained.

New restrictions

Briefing the media about the decisions taken by the NCC, Federal Minister for Planning Asad Umar said a comprehensive plan will be prepared in consultation with the provinces in case lockdowns become necessary in certain cities.

"All schools will be closed in cities where the positivity ratio is above 5% till Eid. Classes 9-12 will also not be held in-person," he said. He further said that outdoor dining is also being banned till Eid and only takeaway is allowed. Indoor gyms have also been ordered to close down under the new

Asad Umar said that markets will be closed by 6 p.m. except for essential services and a list will be issued of those businesses that are allowed to operate.

The federal minister said that a decision has also been taken to restrict office timings until 2 p.m. so that people can do Eid shopping easily within the time limits set by the government.

"The 50% work from home policy will continue," he added. He also urged the masses to not wait for the last three days of Ramadan for Eid shopping so as to avoid a rush in marketplaces. Regarding air travel restrictions, Asad Umar said a detailed policy is being made under which the number of passengers coming to Pakistan will be cut down. "[Matters relating to] passengers' testing and quarantine will also be decided," he said.

Pakistan, the minister said, is utilizing 90% of the oxygen already being produced, so the government is working to enhance capacity and will import the gas if needed. Difficult decisions

PDA backs students, challenges PMC's 60% requirement

ARACHI - Pakistan Dental Association (PDA) recently submitted a counter-affidavit to confirm that set of pleas challenging the 60% marks condition for eligibility in written bachelors of dental surgery (BDS) admission test should be granted and found no objection in the application.

The official copy of the document available with Dental Tribune Pakistan read that Dr Mahmood Shah, president PDA, was aware of the case. It read that the Sindh Court should grant interim relief to

The document read, "No tangible and reasonable explanation has been given by Pakistan Medical Commission for this abrupt rise of MDCAT qualifying exam percentage."

The document further stated that the abrupt increase in merit leads to an admission crisis. "This decision of Pakistan Medical Commission (PMC) has created an acute admission crisis whereby



approxiamately 650 BDS seats are lying vacant."

Earlier, The Sindh High Court issued notices on March 15 to the Pakistan Medical Commission over a set of pleas challenging the 60% marks condition for eligibility in written bachelors of dental surgery (BDS) admission test.

The petitioners contend that the PMC initiated its admission process but restricted students with below 60% marks in their intermediate exams from sitting for the entrance

The petition mentions that there are 690 BDS seats in the province, and 515 of them are vacant. During the hearing, the petitioners' counsel, Haider Waheed, argued that the minimum 60 per cent mark requirement was unjust with students.

He moved the court to issue a stay on the restriction. Upon inquiry, the court was informed that the petition had been filed by students, medical colleges, and a non-governmental organisation.

PMC representatives, however, stated that they had not received any notices yet. The court sought the entire BDS admission records and a reply from the PMC by the next hearing slated for March 22.

DRAP allows resumption of vaccination administration

SLAMABAD - The Drug Regulatory Authority Pakistan (DRAP) has allowed recently the privatelyowned Shifa International Hospital and Islamabad Diagnostic Centre (IDC) to resume the administration of coronavirus vaccination.

The regulator had authorised AGP Limited to be the first company to import Sputnik-V vaccine in Pakistan for private sales. On April 7, the DRAP had stopped both the centres from administering Sputnik V supplied by AGP Limited for deviating from the recommended vaccine storage temperature.

According to it, critical observations regarding deviation from recommended storage temperature (-18°C and below), which is mandatory to ensure safety and efficacy of the said



biological product and absence of documentary evidence regarding authorised distributor/vaccine centres have been reported to the higher authorities.

However, the DRAP has, now, allowed both the facilities to continue the administration of the Sputnik vaccine and asked them to take necessary measurements to ensure documentation of storage conditions in accordance with Emergency Authorisation. It also asked both of them to train their employees in handling the temperature of sensitive products.



Dental Tribune Pakistan: Prof. Nasir, what are the recent advancements in dental field and technology?

Prof. Nasir Ali Khan: We all know that necessity is the mother of all invention. Speaking of dental research, there is a huge shift towards evidencebased dentistry and clinical-based research. This leads to clinical implementations and so on. As far as technology is concerned, there are new advancements such as digital X-ray and CAD/CAM. Then there is a technology that can detect any issues pertaining to the oral cavity. In addition to that, invisible aligners are replacing conventional braces. There is a scope, that can detect oral diseases such as oral cancer by emitting special light. Furthermore, there are intraoral cameras and X-rays. The latest advancements in the dental X-rays consists of technologies that emit less radiation as compared to the conventional ones and are faster. Similarly, there are whitening options that give better results in a single sitting. Nitrous oxide is gaining popularity as an anesthetizing agent, as it allows patients to remain conscious and interact with the dentist. Moreover, there is a new diagnostic tool that can detect any dental caries in mouth.

There are issues everywhere, including the dental OPDs. These include problems with infrastructure and finance. I want the administrative department of KMDC to join hands to build a better system and infrastructure

These are some of the interesting advancements I have come across with.

You have recently been appointed as the in charge of OPD, any plans to improve it.

It has been a few days since I took charge of dental OPDs at KMDC. To be honest, there are issues everywhere including the dental OPDs. These include problems with infrastructure and finance. You will be surprised to hear that despite earning in millions, we do not have the authority to spend that money. There is of lack of dental materials, equipment, and dental units along with poor maintenance. I would like the administrative

Prof. Nasir Ali Khan is secretary general, Pakistan Dental Association (PDA) head of the Department of Oral Biology.

After completing BDS from Liaquat University of Medical and Health Sciences, Jamshoro, Pakistan in 1992, Prof. Dr Nasir joined as house officer in Liaquat National Hospital. He later on performed his duties as resident medical officer (RMO) in LNH from 1994 to 1997.

He formally started his career as demonstrator in 1997 at Karachi Medical and Dental College (KMDC). In 2002, Prof. Dr Nasir was promoted as assistant professor and later on was appointed as head of Department of Oral Biology in KMDC. Later, he served as associate professor and went on to become a full professor in 2007.

Prof. Nasir is currently serving as Incharge Dental OPD, Karachi Medical and Dental College (KMDC). He is also covener, Department of Oral Biology, University of Karachi.

Among many feathers in his cap, Prof. Nasir was also member of Pakistan Medical and Dental Council (PMDC) in 2005. He was also vice president, PDA Sindh Zone from 2012 to 2016.

Dental Tribune Pakistan recently spoke to him about his contributions to the dental profession and his struggle for the betterment of the field in Pakistan.

Would you like to enlighten us about PDA, its core objectives and your achievements as its secretary general?

As you know, we joined as the office bearers at

PDA in 2019 and most of our tenure was during the pandemic. We tried to deliver to the best of our abilities despite this challenge. 19 associations have been formed in various cities of Pakistan. We arranged for elections for the first time in Pakistan. Two national conferences and one virtual international dental conference were held in collaboration with Dental Tribune Pakistan. Achieving everything on merit is one of our goals. Two dental faculty members were sent from Pakistan, as foreign speakers to deliver lectures abroad. This could not be achieved earlier due to the presence of nepotism. There have been events pertaining to the World Oral Health Day, including walks and competitions. Concerns regarding the PMC ordinance have been raised on electronic platforms as well as the print media. We met with the honourable President of Pakistan, Dr Arif Alvi and spoke to him about the issues. The meeting went on for an hour and we discussed the involvement of stake holders to compile the PMC regulations to avoid any problems. As secretary general of PDA, I am trying my best to guarantee effective running of association. It is a pity that PDA never had an audit since its inception in 1962. We are the first cabinet to organize a comprehensive audit for 2018, 2019 and 2020. Efforts are being made to streamline the registration process. The tentative date for APDC has been confirmed for 2023, after a 17-year gap. I would request Dr Arif Alvi to support us and declare it as national event.

We met with the honourable President of Pakistan, Dr Arif Alvi and spoke to him about the issues. The meeting went on for an hour, and we discussed the involvement of stakeholders to compile the PMC regulations to avoid any problems?

What are the benefits of joining PDA for young graduates?

PDA being a national level association, provides fresh graduates with a platform to highlight their issues. They can voice their concerns regarding the newly introduced exit exam by the PMC. Secondly, they can participate as a PDA member and avail many opportunities in international conferences. We are also trying to introduce insurance policies and grants for them to open up clinics, research etc.



Students showcase posters at competition, highlight COVID SOPs

ONDON, UK - As world leaders are continuing to roll out vaccination programmes and encouraging the public to get vaccinated, one thing is clear: there are still people who refuse or delay their vaccinations. Healthcare workers are a priority group since they run an elevated risk of infection. However, in a recent study, researchers found that vaccine hesitancy prevails in around a quarter of healthcare workers in the UK and that, compared with their white British colleagues, some ethnic minority groups show more resistance to getting vaccinated.

The UK Research study into Ethnicity And COVID-19 outcomes in Healthcare workers (UK-REACH) study is among the largest and most comprehensive vaccine hesitancy studies to date and was launched after mounting evidence showed that people from ethnic minority backgrounds had double the risk of severe COVID-19 disease compared with the risk for the white population. The research is funded by UK Research and Innovation and the National Institute for Health Research and supported by large national professional regulatory bodies.

In the study, the researchers analysed ethnic differences in SARS-CoV-2 vaccine hesitancy among 11,584 healthcare workers. They considered factors such as demographics, vaccine trust and perceived risk of COVID-19 and found that, despite the increased risk of infection, 23% of the participants reported vaccine hesitancy. (54.2%), Mixed White and Black Caribbean (38.1%) and Black African (34.4%) ethnic groups were found to

be significantly more hesitant than white British healthcare workers. of which group 21.3% were found to be hesitant.

According to the data, independent predictors of

hesitancy include younger age, female sex, a higher score on a COVID-19 conspiracy beliefs scale, lower trust in employer, lack of influenza vaccine uptake in the previous season,

workers from Black Caribbean previous COVID-19 and pregnancy. After analysing qualitative data from 99 participants, the researchers also found that there was a lack of trust

> in government and employers a m o n g t h e participants. Additionally, the participants expressed safety concerns owing to rapid vaccine development, lack

of ethnic diversity in vaccine studies, and confusing and conflicting information.

In light of the findings, the researchers urged the government to develop strategies that would help build trust among ethnic minority groups and dispel myths surrounding the SARS-CoV-2 vaccine in the respective communities. They concluded that any communication regarding public health should be inclusive and that the government should promote vaccination through trusted websites.

Commenting on the results, General Dental Council (GDC) Executive Director of Strategy Stefan Czerniawski said in a press release: "We encourage all dental professionals to be vaccinated as an important step in protecting their patients, their communities and, of course, themselves."

"This research shows that most healthcare workers-including dental professionals-recognise that vaccines are safe and effective, but that a minority remain hesitant. It's important to understand the reasons for that so that concerns can be addressed, and take-up encouraged," he added.

Czerniawski commented that the GDC will continue to seek opportunities to promote a wide vaccination take-up and to show their support for the findings of the study. Additionally, the organisation has recently updated its vaccination guidance for dental professionals and employers and encourages dental professionals to read it.

SARS-CoV-2 might enter lungs through gingivae, experts say

EIPZIG, GERMANY - As the COVID-19 pandemic has progressed, more and more has been discovered about the virus and disease. Previously, it was assumed that SARS-CoV-2 infected the lungs only via the upper airways. Now, another hypothesis has been formally published that suggests that the virus is transmitted via a vascular route from the oral cavity to the lungs.

The research team of scientists from Salisbury District Hospital and the University of Birmingham in the UK and the Mouth-Body Research Institute in Los Angeles in the US and Cape Town in South Africa has proposed that dental plaque accumulation and periodontal inflammation make it more likely that SARS-CoV-2 will reach the lungs from the mouth and cause more severe cases of infection.

Initial observations of lung CT scans of patients suffering from COVID-19 lung disease by consultant radiologist Dr Graham Lloyd-Jones, who is lead author of the hypothesis, led to a collaboration between medical and dental researchers on the potential entry route into the bloodstream.

The team's model proposes that the mouth provides a reservoir for the virus to thrive in the saliva and any breach in oral immune defences makes it easier for the virus to enter the bloodstream. Moving from blood vessels in the gingiva, the virus is hypothesised to pass through the neck and chest veins to the heart before being pumped into the pulmonary arteries and small vessels in the lung base and periphery.

Co-author Dr Iain Chapple, professor of periodontics at the University of Birmingham, commented: "This model may help us understand why some individuals develop COVID-19 lung disease and others do not. It could also change the way we manage the virus-exploring cheap or even free treatments targeted at the mouth and, ultimately, saving lives."
