IADS General Assembly

IADS Experience is a section where you can find reports from IADS and also other dentistry events that our members have attended. This way you can get an idea of how our events look like and what to expect if you want to attend a similar event in the future. Even though the General Assembly (GA) is the supreme authority of our association, often our members don't really know what is happening at its meetings. So for the first part of this article, we are going to take a step back and present the GA in general, and in the second part, you can find the report from our most recent GA that happened at the 66th IADS Mid-Year Meeting in Bosnia and Herzegovina.

When does the GA meet?



GA is the core event of the IADS meetings. IADS organizes two main meetings every year; Annual Congress (AC), which normally takes place at the end of the summer and Mid-Year Meeting (MYM) at the end of winter/beginning of spring. Usually, two full days of the meeting are reserved for the GA. Members should be informed about the dates of the GA at least 6 weeks prior to the opening session.

Who is present at the GA?

While the majority of participants at our meetings are listening to interesting lectures, practicing new skills in workshops or working on their soft skills in training sessions, official delegates from our Member Organizations participate in the GA. Each Member Organization can be represented with up to 2 official delegates. **Full Member delegates** have a right to speak and vote, while **Corresponding and Affiliate Members** don't have the voting right. **Executive Committee (ExCo)** members cannot be delegates, which means they don't have the voting right, while the rest of **Leadership** can represent their member associations as well. **Honorary Life Members** have the right to speak at the GA. **Observers** can be either IADS members who are not the delegates or guests from other international organizations and only have a right to speak on the permission of the GA. Motions passed by the GA are considered valid when 1/3 of the full members who are up to date with their membership fees are present.
