## HHS launches portal for potential vaccinators

*Dentists who are interested in administering COVID-19 vaccines are encouraged to sign up*

As vaccine supply continues to increase in the coming weeks and all adults across the United States become eligible for vaccination, the U.S. Department of Health and Human Services has launched an online portal to help dental providers navigate the training and registration they

will need to complete in order to become a part of the expanded COVID-19 vaccine workforce.

Health care professionals, retirees and students can now visit the Emergency System for the Advance Registration of Volunteer Health Professionals, at [www.PHE.gov/COVIDvaccinators](http://www.PHE.gov/COVIDvaccinators), for information on whether they are eligible to administer the COVID-19 vaccine under federal law.

The site also includes links to volunteer management portals for every state, for

those professionals and students who wish to volunteer as vaccinators.

HHS is conducting a significant outreach effort to health professional associations, schools of health professions, public health and emergency management stakeholders, and state and local health officers and immunization managers to share vaccinator eligibility information and get the word out about volunteer opportunities.

The Emergency System for the Advance Registration of Volunteer Health Profes-

sionals website verifies health professionals’ identities, licenses, credentials and accreditations in advance so that state and territorial health agencies can determine the best way to use available COVID-19 vaccinators to help their communities.

“Some vaccinators may not be called to serve, but by registering you are making the commitment to help the people

# Silent partners invest in great dental practices nationwide

*Higher taxes in 2022 are accelerating this trend*

The national consolidation of dental practices has accelerated in the COVID era. Larger practices of all specialties are achieving record values by selling a part of their practice to silent partners for cash now and greater wealth later.

Doctors remain as owners and continue to lead their practice for years or decades with their brand, team and strategy. They diversify their personal net worth and benefit from the resources of a larger, silent partner to reduce administrative headaches, gain superior marketing, reduce costs and receive higher reimbursement rates.

### Increased taxes in 2022 and beyond

President Biden has repeatedly committed to eliminate the long-term capital gains tax treatment for those earning more than \$400,000 per year. A sale of part of your practice in 2022 and beyond could result in the doubling of your federal tax rate from 20 percent to about 40 percent.

This would be in addition to state tax in 43 states. Doctors in New York, California and other states could be facing total taxes in 2022 of more than 50 percent.

in your community if they need you. You could even administer a dose of vaccine that saves someone's life," wrote HHS on the Emergency System for the Advance Registration of Volunteer Health Professionals website.

The Public Readiness and Emergency Preparedness Act, or PREP Act, allows the HHS secretary to issue a declaration in a

public health emergency such as a pandemic. This declaration provides temporary immunity from tort liability claims (except willful misconduct) to individuals or organizations involved in dispensing medical countermeasures such as vaccines.

During COVID-19, a declaration was first issued in January 2020 and was amended on March 11 to designate additional health care professionals, including dentists, as "qualified persons" who

are authorized to administer COVID-19 vaccines.

Dental students who have the proper training and professional supervision are also among those providers authorized under the declaration.

## AAOMS advocates for legislation to provide insurance coverage for congenital craniofacial anomalies

All private group and individual health insurance plans would be required to cover medically necessary services resulting from birth defects under bipartisan federal legislation introduced in March in both the House and Senate.

The Ensuring Lasting Smiles Act — championed by the American Association of Oral and Maxillofacial Surgeons (AAOMS) — was re-introduced March 16 by U.S. Sens. Tammy Baldwin (D-Wis.) and Joni Ernst (R-Iowa) along with U.S. Reps. Anna Eshoo (D-Calif.) and Drew Ferguson (R-Ga.), who also is a dentist.

The legislation (S 754/HR 1916) would address delays and denials in coverage (including plans regulated by the Employee Retirement Income Security Act of 1974) to ensure patients suffering from birth defects, also known as congenital anomalies, receive the treatment they need in a timely manner.

These treatments could include adjunctive dental, orthodontic or prosthodontic support. The bill excludes coverage for cosmetic surgery to reshape normal

structures of the body to improve appearance or self-esteem.

While many private health insurance companies cover preliminary procedures for congenital anomalies, they routinely deny or delay follow-up or corrective procedures — notably, dental-

related procedures involving orthodontia and dental implants — deeming them cosmetic or covered by dental plans.

Severe dental anomalies are a common symptom of many craniofacial anomaly conditions, but coverage limits in dental plans are not nearly as robust as that

of health plans. As a result, patients are often forced to incur significant out-of-pocket costs on medically necessary reconstructive dental care related to their disorder during their lifetime.

“AAOMS is passionate about advocating for health coverage on behalf of our patients with craniofacial anomalies,” said AAOMS President B.D. Tiner, DDS, MD, FACS. “We were disappointed that — despite more than 300 bipartisan House cosponsors and 50 bipartisan Senate cosponsors — the 116th Congress did not pass the bill. We look forward to working with the bill sponsors and other patient and provider organizations to get this bill over the finish line this Congress.”

The Centers for Disease Control and Prevention classifies birth defects as “common, costly and critical” and reports that one in 33 U.S. newborns suffers from a congenital anomaly. Craniofacial anomalies — deformities in the growth of the bones in the head and face — can restrict a patient’s ability to breathe, eat and speak. Early intervention by a team of specialists is regarded as necessary to assess and oversee the patient’s treatment and development, often over the course of many years.

# Dr. John J. Stropko, inventor of Stropko Irrigator, retires

After six decades in dentistry, John J. Stropko, DDS, a microendodontist and inventor, has retired. He has handed the manufacturing and sale of the Stropko Irrigator to Vista Apex.

Dr. Stropko had an extensive career. After receiving his DDS from Indiana University in 1964, he served as a captain in the Air Force Dental Corp until 1966. For the next 24 years, he had a private practice limited to adult restorative dentistry. In 1987, he was accepted into the post-graduate endodontic program to study under Dr. Herbert Schilder at Boston University and received his Endodontic Specialty Certificate in 1989.

Stropko had many achievements in his career. In 1995, as an adjunct assistant professor, he was responsible for starting the micro-endodontic program at Boston University. He contributed to textbooks and published an extensive clinical morphology study in the *Journal of Endodon-*

tics in June 1998. He is also a well-known lecturer with numerous presentations and live micro-surgical demonstrations given worldwide.

With its slow rotation, the TruGrit Trough Refiner offers increased opera-

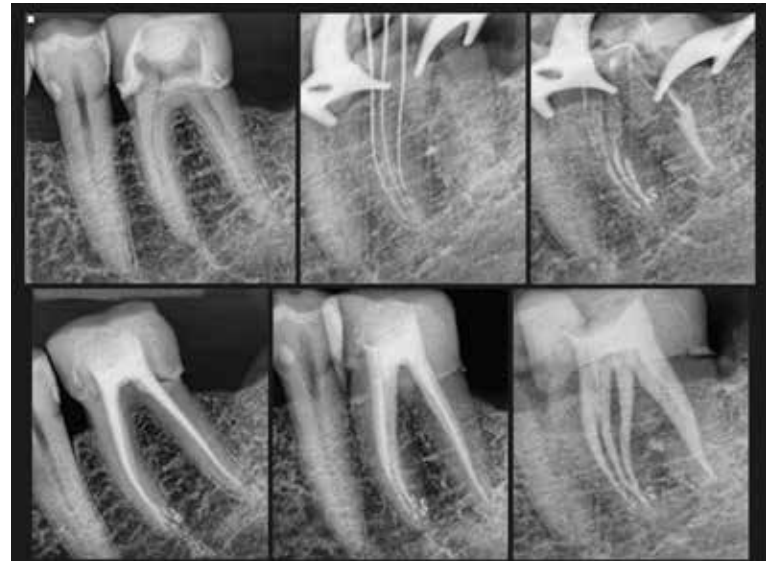
