


- "To Contract or Not to Contract? Working with Dental Benefit Contracts" by Lisa Greer and Matthew Nelson, 11a.m.–noon Friday, in The Spot, Hall D. With so many different dental benefits plans on the market, how do you select the right ones? This session will focus on the pros and cons of contracting with dental benefits plans in your practice.

- "Embezzlement Controls" by Matthew Nelson, 2–3 p.m. Friday, in The Spot, Hall D. In this session, dental practice and policy expert Nelson

will review best practices for embezzlement and audit controls. He will also address common scenarios that dentists encounter with their staff.

- "Ask the Expert: Dental Benefits" by Lisa Greer, 3–4 p.m. Friday, in The Spot, Hall D. Greer will review the top 10 dental benefits questions asked by dentists and their staff.

- "Ask the Expert: HIPAA Compliance Essentials" by Teresa Pichay, 2–3 p.m. Saturday, in The Spot, Hall D. More than 20 years after HIPAA became law, practices continue to struggle with understanding what is necessary to be compliant. Pichay will

review the essential elements to compliance with patient rights, uses and disclosures of information requiring patient authorization, required and addressable safeguards, written policies and procedures, employee training and discipline and conducting a risk analysis. Attendees will leave with a checklist to guide their efforts.

After each session, CDA's team of experts will be available for one-on-one guidance at the member Benefits Center at booth No. 1102.

Honoring the late Dr. Soderstrom, co-founder of CDA Cares

The late Dr. Andrew Soderstrom, for whom the Humanitarian Award is now named, received the award himself in 2015.

The CDA past president co-founded the foundation's flagship program, CDA Cares, an all-volunteer run dental clinic, and continuously served the dental needs of children, regardless of their families' economic situation.

He was also recognized for a long-fought battle to fluoridate community

water in his hometown of Modesto, Calif.

More recent recipients include Herbert Yee, DDS, in 2018, and Lester Low, DDS, in 2017.

Selection criteria and required documentation from nominators

Nominators must submit several attachments with their online application, including a curriculum vitae or resume highlighting the nominee's humanitarian contributions and one letter of support from an individual other than the nominator.

Among other humanitarian ideals and attributes, nominees should:

- Demonstrate a lifetime of outstanding humanitarian volunteer accomplishments that bring honor to the profession.

- Serve as an inspiration to the dental profession.

- Show selflessness in regard to direct personal or organizational gain or profit.

Recipients of the award are typically presented with the Humanitarian Award at an appropriate CDA event and recognized in CDA and CDA Foundation publications in the fall. When funding is available, a monetary contribution may be given to the recipient's nonprofit of choice.

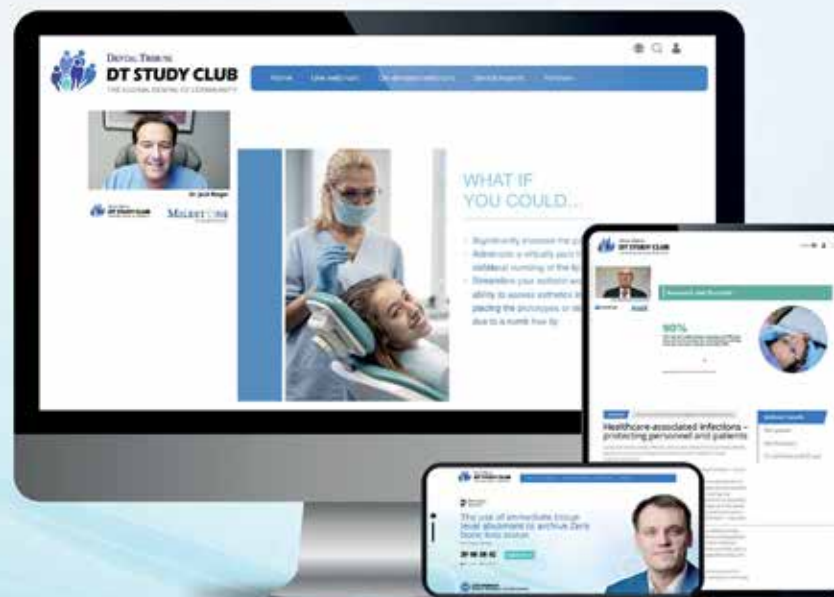
